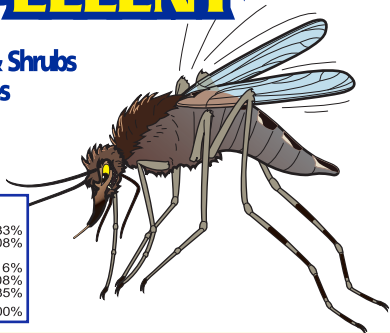

APPLICATION DIRECTIONS

SHAKE CONTAINER WELL BEFORE APPLYING ST. GABRIEL LABORATORIES' MOSQUITO REPELLENT.

Rains may wash Mosquito Repellent off treated vegetation. Treatment should be repeated after heavy rains. Do not apply Mosquito Repellent when rain is expected within the next 4 hours.

Recommended Application: To achieve best results, begin treatment two weeks prior to insect emergence. Continue application every four weeks to ensure best control. Effective for repelling mosquitoes, ticks, fleas and gnats for two to four weeks per application.

Areas to apply: open lawn, trees and shrubs, ornamentals, bushes, and around patios, pools and foundations.

Coverage: 5,000 square feet.

STATEMENT OF PRACTICAL TREATMENT/FIRST AID

IF IN EYES: For contact with eyes, flush with plenty of water. If irritation develops and persists, get medical attention.
